1/5-10-21 Apologies

Apologies were received and accepted from Cllr P Shipley and Borough Cllr B Ashcroft advised that she was unable to attend.

3/5-10-21 Minutes of Previous Meeting:

Staffordshire police report was noted. Clerk was asked to promote some of the crime prevention initiatives.

i) Woodland management plan

Cllr Bristow and Clerk had met Liz Sharkey to establish plans for the woodland for the next 5 years.

Liz had commented on how well the woodland had been planted.

Liz had suggested that the east side of the woodland, semi-circular area, be identified for regeneration. Land preparation would be required and also a felling licence which she could assist the council with.

There is also parcel of land which runs alongside Princes Wood with Aggregate Industries own. Clerk was asked to contact the land owner to establish their longer-term intentions in relation to this land.

There was a discussion in relation to the north east boundary of the woodland. Clerk and Cllr Bristow to look at the deeds.

Derbyshire Wildlife Trust had contacted the parish council. They are interested in using Princes Wood for training purposes. Council agreed that Cllr Bristow would meet them to establish what works they could carry out in line with the plan which Liz had drafted as possible options.
