# 053/23-24 Apologies

Apologies were accepted from Borough Councillors J Jones, V Gould, B Ashcroft, and County Cllr J Jessel.

#### 054/23-24 Declaration of interest and dispensation requests from members.

Cllr E Coleman wished to declare an interest when the proposed Princes Wood car park was discussed.

#### 055/23-24 Minutes of the meeting for approval – 12 September 2023

Members were happy that the Chairman signed the minutes as a true and accurate record.

#### 056/23-24 Chairmans report

The Chairman informed members of the discussions he has had with Chairs of other parish councils.

The Chairman has commenced initial investigations to establish what consents would be required should the Council proceed with exploring the feasibility of a Car Park near to Princes Wood.

# 057/23-24 Clerks report

The Clerk advised that no response had been received yet from The Woodlands Committee following boundary tree enquiries. Members felt to give it a few more weeks.

Newsletter – The clerk reminded members that articles for the newsletter were required please by 31<sup>st</sup> October if members still wished a newsletter to be distributed to residents the week before the Christmas Fair.

Members agreed that the Chairman and Clerk finalises the newsletter and sends for publication. Copies for distribution will be given to members at the November meeting.

Additional Finger post, Princes Wood – The additional finger post has been installed. Members were very happy with the work.

Traffic Calming Feasibility Study – Council requested that the Clerk speaks to County Cllr J Jessel to obtain her support in progressing the project.

SPCA Bulletin – Members were happy to receive the Weekly SPCA Bulletin.

Rangemore Sign – There was a lot of discussion in relation to the existing sign. The Clerk had been asked to establish any additional protection method as the wood was rotting. It was suggested that the sign be formally handed over to the villagers who would decide where it could be stored to preserve it.

There was a discussion about a bespoke Rangemore and Tatenhill Sign. The Chairman requested that it be an agenda item for next month.

It was noted that Rangemore Community Garden achieved a Level Four at the recent annual Neighbourhood Award hosted by In Bloom.

It was noted that that a consultation was currently open for polling districts and polling places. Closing date 30<sup>th</sup> November 2023.

It was noted that Rev Terry Williams had taken up the position as Minister of the Benefice of Hanbury, Newborough and Rangemore. Clerk to circulate information to parish councillors.

The Freedom of Information request was noted.
